- 1.1. "Contract" means the documents forming the tender and the acceptance thereof and the formal agreement executed between B.C.C Bank and PMC, together with the documents referred there in including these conditions and instructions issued from time to time by the Bank and all these documents taken together shall be deemed to form one contract and shall be complementary to one another.
- 2. The PMC must be equipped with adequate expertise and experience in undertaking Planning, designing & implementing/execution of Civil, Landscaping work, Interior works and all essential and ancillary works/services required for construction and completion of Interior works and new buildings.

Eligibility criteria:

- (i) Minimum 5 years' experience as a PMC as on 31.08.2025. The experience should include all consultancy services for buildings such as architectural, structural, engineering, Interior and Furnishing and all internal and external services such as electrical, AC, plumbing, water supply, soil, firefighting, etc.
- (ii) The PMC should have rendered satisfactory professional services in planning, designing & supervision of similar building construction projects, from inception to completion stage.

- b. If the contract is terminated under any termination clause, the PMC shall handover all design documents/ executable/ B.C.C Bank's data or any other relevant information to the B.C.C in timely manner and in proper format/soft copies as well as hard copies as per scope and shall also support the orderly transition to another PMC as decided by the B.C.C Bank.

8. Termination for Convenience

b.Price Bid quoted should be inclusive of all Central / State Government taxes/duties and levies but exclusive of GST.

- c. Fee payable to the PMC as stated in the Agreement shall be firm and not subject to adjustment during execution of the Project, irrespective of reasons whatsoever, including exchange rate fluctuations etc.

The PMC who scores maximum marks put together for technical bid and price bid shall be considered for selection.

- a) The final selection of PMC will be made on the basis of techno-commercial evaluation by assigning weightages in the ratio of 50% to the presentation scheme (various technical parameters) made before the committee and 50% to the price bid (professional fee quoted in sealed cover).
- b) Both scores (technical & price bids) will be converted into percentile score and weighted combined score will be worked out to determine the highest scoring PMC firm to whom the project will be awarded after obtaining approval from the competent authority.

The weightage given to the bids are as below:

- EXAMPLE IS GIVEN BELOW:
- Suppose three applicants are short listed as A, B, & C based on technical bid scrutiny and they secured marks out of 50 as under:
 - O A 45 marks;
 - O B 43 marks;
 - O C 40 marks
- As 'A' secured highest marks in technical evaluation, to work out percentile score, following will be the calculation:
 - O A: (45/45) X 100 = 100
 - O B: (43 / 45) X 100 = 95.55
 - O C: (40 / 45) X 100 = 88.88
- Now that technical bids are evaluated, financial bids can be opened.
- Financial quotes for three bidders are as follows:
 - O A: 3.00 %
 - O B: 2.50 %
 - O C: 2.10 %
- As 'C' has quoted lowest price, to work out percentile score, following will be the calculation:
 - O C: (2.10 / 2.10) X 100 = 100
 - O B: (2.10 / 2.50) X 100 = 84
 - O A: (2.10 / 3.00) X 100 = 70

Since proportion of technical to financial score is specified to be 50:50, then final scores will work out as follows:

O A: (100 X 0.50) + (70 X 0.50) = 85 O B: (95.55 X 0.50) + (84 X 0.50) = 89.77 O C: (88.88 X 0.50) + (100 X 0.50) = 94.44

From the above, the most successful applicant would be the one with highest percentile score i.e. 'C'.
